Due to the nature of our business, we recommend that everyone go through the policy and obtain any required consents, or to have another legally sufficient legitimate basis for processing, if applicable.

INFORMATION WE MAY COLLECT Our Services gather certain information, some of which may be considered personal information under applicable law.

We and users of our Services, including without limitation, our customers and partners such as third-party service providers with whom we collaborate to complete the transaction, may collect, among other things, the following types of information:

- Name
- Address (including billing and shipping addresses)
- Telephone number
- Email address
- Fax number
- Professional information, such as employer or organizational affiliation for a customer or partner, or company or organizational entity name for a delivery pickup, transfer or destination location



- Payment or financial information in order to process a purchase or transaction or for shipping fees
- Unique IDs such as a cookie placed on a computer or mobile device, or device IDs
- IP address or MAC address, and information derived from an IP or MAC address, such as geographic location
- Browsing activities, cookies and similar data, and platform or mobile application use data
- Referring domain, destination domain and destination path
- Geo-locational data, including latitudinal and longitudinal data
- Routing, pickup, transfer and delivery time and route information
- User IDs and passwords for customers or partners with accounts on our Services
- Information required by customs or other governmental authorities
- Communication preferences
- Other similar information

We, and users of our Services, may also collect information, including personal information, in the following situations:

Registration for the UTC Services: Information such as name, email address, telephone number, company/organization, title, and other information may be collected in connection with registration for or use of the UTC Services (for example, to sign up for and log into the UTC websites and portals). Customers may update their information by logging into their account.

Use of UTC Services. Customers and others using our Services, such as retailers, distributors, freight forwarders, manufacturers, and logistics service providers, may collect information they need for their supply chain and trade logistics. Certain customers, such as insurance brokers or agents, may also collect certain information that may be regarded as sensitive in certain jurisdictions. We rely on such customers to obtain any required consents, or to have another legally sufficient legitimate basis for such collection if applicable.

Communications. Personal information may be collected, such as name, email address, and other information, when provided in any communications, whether via email, social media, phone or otherwise, including for support-related questions.

Surveys and Research. We may collect personal information from anyone participating in research and surveys.

Compelled Disclosures : UTC may be required to disclose personal Data in response to lawful requirement by public authorities, including to meet the national security or law enforcement requirements.

USE OF INFORMATION : UTC may use the information, including personal information, collected in connection with the Services for the purpose of providing the Services to our customers, as well as for supporting our business functions, such as fraud prevention, marketing, analytics and legal functions and other legitimate purposes. Our customers may use such information in connection with their use of our Services.

To the extent permitted by applicable law and, for customer data, as permitted by our customer agreements, we may use information collected in connection with our Services:



- To operate the UTC Services and provide support.
- To fulfill customer requests, such as to create a UTC Services account or complete customer purchases.
- To communicate with our customers; to inform customers and users of products, programs, services and promotions.
- To send customers information regarding the UTC Services and issues specifically affecting UTC Services
- To respond to reviews, comments, or other feedback provided to us.
- To support and personalize our Services, websites, mobile services, and advertising.
- To protect the security and integrity of our Services, content, and our business.
- To provide support; for other business purposes, such as benchmarking, data analysis, audits, developing new products, enhancing the UTC Services, facilitating product, software and applications development, improving our services, conducting research, analysis, studies or surveys, and identifying usage trends.

To meet our contractual requirements, to comply with applicable legal or regulatory requirements and our policies, to protect against criminal activity, claims and other liabilities.

For any other lawful purpose for which the information is provided.

We may use, process, transfer, and store any data in an anonymous, aggregated manner. We may combine personal information with other information, collected online and offline, including information from third party sources.

In addition, we, and customers using our Services, may also use cookies and other tracking technologies such as beacons, tags, scripts and other similar technologies, including cross-device tracking. The purposes of such use may include benchmarking, metrics, analytics, quality assessment and other lawful purposes. Please visit our Cookies Policy for more information on these practices.

We, and our customers, may also use information in other ways with consent or as permitted by applicable law.

Aggregate Information. To the extent permitted by applicable law, we may use, process, transfer, and store any data about individuals and about customers or partners in an anonymous (or pseudonymous) and aggregated manner. We may combine personal information with other information, collected online and offline, including information from third party sources. We may also use information in other ways with consent or as permitted by applicable law. By using the UTC Services, our customers and partners agree that we are hereby licensed to collect, use, share and store anonymized (or pseudonymized) aggregated data collected through the UTC Services for benchmarking, analytics, metrics, research, reporting, machine learning and other business purposes.

Automated Decisions. To the extent permitted by applicable law, we may collect data in an automated manner and make automated decisions, including using machine learning algorithms, about individual users of the UTC Services in order to provide or optimize the UTC Services offered and/or delivered, for security or analytics purposes, and for any other lawful purpose. To the extent permitted by applicable



law, we may use automated decisions, for example, to display advertisements and offers based on the individual's preferences.

SHARING OF INFORMATION : To the extent permitted by applicable law, UTC may share and disclose information, including personal information, as set forth below:

- **Customers.** We may share information with our customers and their service providers and other platforms that may assist those customers.
- **Affiliates and Agents.** We may share information with our affiliates or any business partners or agents acting on our behalf.
- **Service Providers.** We may share information with our service providers, agents, vendors and other third parties we use to support and advertise the UTC Services and our business. We share personal information with such third parties to the extent necessary to provide services to us, and pursuant to binding contractual obligations.
- **Advertising and Marketing.** To the extent permitted by applicable law, we may share information with third parties for marketing, advertising, promotions, contests, or other similar purposes. If required by applicable law, we will share such data for advertising and marketing purposes only in an aggregate, anonymous, and de-identified manner.
- **Mergers, Acquisitions, Divestitures.** We may share, disclose or transfer information to a buyer, investor, new affiliate, or other successor in the event UTC, or any affiliate, portion, group or business unit thereof, undergoes a business transition, such as a merger, acquisition, consolidation, reorganization, divestiture, liquidation or dissolution (including bankruptcy), or a sale or other transfer of all or a portion of any assets of UTC or any affiliates or during steps in contemplation of such activities (e.g., negotiations and due diligence).
- **Law Enforcement and National Security.** We may share information with legal, governmental, or judicial authorities, as instructed or required by those authorities or applicable laws, or to comply with any law or directive, judicial or administrative order, legal process or investigation, warrant, subpoena, government request, regulatory request, law enforcement or national security investigation, or as otherwise required or authorized by law.
- **Protection of Rights, Property or Safety.** We may also share information if, in our sole discretion, we believe disclosure is necessary or appropriate to protect the rights, property or safety of any person, or if we suspect fraud or other illegal activity,

UTC may also disclose personal data for other purposes or to other third parties when an individual has consented to or requested such disclosure, or where a customer has obtained permission from such individual, or where such disclosure is otherwise legally permitted for legitimate business purposes, and, for customer data, only with such customer's authorization or otherwise in accordance with UTC's agreement with such customer.

DATA RETENTION : To the extent permitted by applicable law, we may retain information for as long as the account of the customer for whom we collected the information is active, for at least twenty-four (24) months thereafter, or as long as is reasonably necessary to provide the UTC Services or as needed for other lawful purposes. We may retain cached or archived copies of information. We may retain anonymized or pseudonymized, aggregated data indefinitely, to the extent permitted under



applicable law. We may be required to retain some data for a longer period of time because of various laws and regulations or because of contractual obligations. We also will retain information as long as reasonably necessary to comply with our legal obligations, resolve disputes and enforce our agreements.

CHILDREN'S PRIVACY : The UTC Services are not intended for children under 13 years of age (and for European residents, for children under 16 years of age per our European Privacy Policy). We do not knowingly collect information from children under the age of 13 (or, for European residents, under 16). If we learn we have collected or received personal information from a child without verification of parental consent, we will delete that information. CHOICES AND OPT-OUT: To the extent required by applicable law, or in our discretion otherwise, we will allow our customers, partners and other individuals to limit use and sharing of personal information that complements our services. Please note that these choices do not apply to communications primarily for the purpose of administering order completion, contracts, support, product safety warnings, driver updates, or other administrative and transactional notices.

If a customer, partner or an individual no longer wishes to receive marketing-related communications from us, they may opt out by following the "[unsubscribe](#)" instructions in the latest such message received or by contacting us as indicated below.

SECURITY : The security of personal information that UTC collects and that is collected using our Services is important to us. To prevent unauthorized access or disclosure, to maintain data accuracy, and to ensure the appropriate use of the information, UTC utilizes appropriate physical, technical and administrative procedures to safeguard the information we collect. Unfortunately, no data transmission over the Internet or data storage system can be guaranteed to be 100% secure. Therefore, despite our efforts, we cannot guarantee its absolute security. We do not warrant or represent that personal information about you will be protected against, loss, misuse, or alteration by third parties.

CLASS ACTION WAIVER : YOU AND WE AGREE THAT EACH MAY BRING CLAIMS AGAINST THE OTHER ONLY IN YOUR OR OUR INDIVIDUAL CAPACITY AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PURPORTED CLASS OR REPRESENTATIVE PROCEEDING.

DISPUTE RESOLUTION : Except as otherwise expressly provided above, or in our European Privacy Policy or otherwise required by applicable law, you agree that the exclusive jurisdiction of any actions arising out of, relating to, or in any way connected with, this Privacy Policy, shall be in the state or federal courts, as applicable, located in the City of Houston, TX or NY/NJ. Any dispute, controversy, or claim arising out of or relating to this Privacy Policy or the collection, use, storage or transfer of any of your information or data, including, but not limited to, the arbitrability of the matter or the formation, interpretation, scope, applicability, termination, or breach of this Privacy Policy, shall be referred to and finally determined by arbitration in accordance with the JAMS Streamlined Arbitration Rules and Procedures, or JAMS International Arbitration Rules, if the matter is deemed “international” within the meaning of that term as defined in the JAMS International Arbitration Rules. The arbitration shall be administered by JAMS, shall take place before a sole arbitrator, and shall be conducted in Houston, Texas. If the JAMS International Arbitration Rules apply, the language to be used in the arbitral proceedings will be English. Judgment upon the arbitral award may be entered by any court having jurisdiction. This section shall apply to and require arbitration of all disputes, controversies, and claims, regardless of whether such disputes, controversies, or claims concern a single individual, entity, or other person, multiple individuals, entities, or other people, or classes of individuals, entities, or other people. You hereby consent to receive service of process by electronic means or social media to the extent allowed by the applicable court. This constitutes express agreement of the parties regarding your consent pursuant to United States Federal Rule of Civil Procedure 5(b)(2)(E) and any applicable state (or other jurisdiction) equivalent.

UPDATES AND CHANGES : We may update this Privacy Policy at any time in our sole discretion to reflect changes to our information and privacy practices by posting a revised version of this Privacy Policy on this page or in the UTC Services, or with any notice to individual users if required by applicable law. ONWARD TRANSFER LIABILITY : UTC will process data for the limited and specified purposes consistent with the consent provided by an individual and if UTC makes a determination that it can no longer meet this obligation UTC shall cease processing the data and take reasonable and appropriate steps to remediate. When transferring personal data to a third party acting as an agent, UTC shall:



- transfer such data only for limited and specified purposes

Our legal bases for the processing of Personal Data are: (i) consent and/or (ii) any other applicable legal bases, such as our legitimate interest in engaging in commerce, supporting internal business functions, offering products and services of value to the customers of the UTC Services, preventing fraud, ensuring information and network security, direct marketing and advertising, and complying with industry practices.

Our portal does not allow erasure of any shipment information including the contact details of the people involved for that transaction. Although it does not store any exclusive personal data but it still have your contact information while dealing with the transaction. User accounts can deleted where ever possible and disabled where it is not possible to delete. We are still working with vendors on impact of deleted the data as laws in countries needs the data to be available from 5-7 years.

Encryption : The transmission of data and emails via the internet is generally not encrypted completely however we use SSL layer with 2048 bit encryption where possible. Transfer of data between the offices are all through IPsec secured VPN tunnel with encryption.

Objection. To object, at any time, to Personal Data about you being Processed for direct marketing purposes.

Maps : UTC embeds third-party maps to track the shipments transported across the world as well as the computer information used to track by the end user.

Restriction of Processing. To request restriction of Processing of Personal Data about you for certain reasons, such as, for example, if you consider Personal Data about you collected by us to be inaccurate or you have objected to the Processing and the existence of legitimate grounds for Processing is still under consideration.

Data Portability. To request and receive the Personal Data we have collected about you in a commonly used and machine-readable form.

Right to Withdraw Consent. If Personal Data about you is processed solely based on your consent and not for any other legitimate interest, to withdraw your consent at any time, without affecting the lawfulness of our Processing based on such consent before it was withdrawn, including processing related to existing contracts for our products and services.



Right to Lodge a Complaint with a DPA. If you believe our Processing of Personal Data about you is inconsistent with the applicable data protection laws, to lodge a complaint with your local supervisory data protection authority ("DPA").

Commitment: UTC commits to cooperate with EU data protection authorities (DPAs) and the Swiss Federal Data Protection and Information Commissioner (FDPIC) and comply with the advice given by such authorities with regard to human resources data transferred from the EU and Switzerland in the context of the employment relationship.

We will process any requests in accordance with applicable law and within a reasonable period of time. We may need to verify the identity of the individual submitting a request before we can address such request. Because UTC has limited ability to access data our customers collect and process through the UTC Services, and because such customers generally have the direct relationship with individuals from whom they collect data, please provide the name of the UTC customer believed to have collected or Processed the Personal Data in question through the UTC Services (if applicable). We will refer the request to that customer and, if so, will support them in responding to the request. Please note that, for UTC customers, certain information may be reviewed, corrected and updated by logging into the UTC Services account and editing the profile information.
